

Competition Terms and Conditions: **The Retina South Africa Zanzibar Raffle**

**Society Lottery Scheme is registered with National Lotteries Commission
(NLC Reg. No. 00187/34)**

1. INTRODUCTION

- 1.1 By participating in the Retina South Africa Zanzibar Raffle Competition (“the Competition”), each participant agrees to be bound by the rules, terms and conditions set out herein.**
- 1.2 These Terms and Conditions govern the participation in the Competition conducted by Retina South Africa in accordance with the laws of the Republic of South Africa.**

2. COMPETITION PERIOD

- 2.1 The Competition shall run from 1 August 2026 and shall close at 10h00 on 20 February 2027.**
- 2.2 No entries received after 10h00 on 20 February 2027 will be considered.**

3. ENTRY MECHANISM

- 3.1 Entry into the Competition shall be through the purchase of raffle tickets via the official Retina South Africa online platform at [Shop Zanzibar Competition](#), and/or in-person.**
- 3.2 Each raffle ticket costs R100.00 (One Hundred Rand) and entitles the purchaser to 1 (one) entry into the draw.**
- 3.3 There is no limit to the number of tickets that may be purchased by an eligible entrant.**

4. ELIGIBILITY AND EXCLUSIONS

- 4.1 The Competition is open to all South African residents who are 18 years or older at the date of entry.**
- 4.2 The following persons are excluded from participating in the Competition:**
 - 4.2.1 board members of Retina South Africa;**
 - 4.2.2 employees of Retina South Africa; and**
- 4.3 Immediate family of board members and employees are not excluded from participating.**

5. DRAW AND PRIZE

- 5.1 The draw will be conducted on 20 February 2027 at Cycle Lab Boksburg, Centric Park, C/O Romeo Street and North Rand Road, Boksburg, before an audience and under the supervision of an independent/designated official.**

- 5.3 The prize is not transferable, not exchangeable for cash, and not refundable. No alternative prize will be offered.

6. WINNER NOTIFICATION AND IDENTIFICATION

- 6.1 The winner will be notified via the contact details (email and/or phone) provided at the time of ticket purchase within 3 (three) business days following the draw.
- 6.2 The winner must provide a valid South African identity document or passport to claim the prize.
- 6.3 If a winner does not respond within ten (10) business days of notification, or fails to provide adequate identification, the prize will be forfeited, and a new winner may be drawn at the discretion of Retina South Africa.
